Mental Health Training for Leaders.

17th October 2024

During the early days of the quarter, we held a mental health training for organization leaders at Skyz Hotel Proteia trained by Awesome Minds. One of UNESOs thematic Areas is; To advance the wellness and well-being of leaders. And it's through this that we aimed to equip member leaders with knowledge on causes and how to manage mental health issues.

During the training, leaders were able to understand the effects of mental health issues, early detection of cognitive problems, how to prevent them, and referral linkage/referral pathway for mental health issues among the members. At the end of the training, leaders appreciated UNESO for prioritizing their mental health but also pledged to fundraise and hold similar training for their staff and members on the ground.

Under the UNESO Project of "Advocacy to improve sexual reproductive health rights of sex workers in Uganda", we conducted Two training sessions on Policy Analysis and Policy Advocacy among our members. The training aimed at equipping leaders with Policy analysis skills to understand different

approaches on how policies may inform their advocacy and strengthen their capacities to enable effective advocacy for policies that can lead to improvements in exercising human rights among sex workers. During the training, leaders were able to learn how to identify key advocacy issues and connect them to the legal frameworks, conduct policy mapping, and learnt how they can engage at different decision-making levels of influence.


Dialogue Meeting on the Human Rights Situation of Sex Workers

17th December 2024

In commemoration of the Day to End Violence Against Sex Workers -17th December, UNESO convened stakeholders for a National Dialogue meeting on the Human Rights situation of Sex workers in Uganda. The dialogue aimed at showcasing how sex worker-led organizations, stakeholders, and partners are responding to the prevention of human rights violations, and the progress achieved. But also provide a platform for exchanging lessons learned that could further inspire and support ongoing interventions addressing human rights violations committed against sex workers. At the end, we held a press conference with a statement calling for hate crimes committed against sex workers in Uganda.

International Engagements

EASWA SDGs Training – Kenya

2nd November 2024



Our advocacy office Stellah was able to attend the EASWA training on SGDs for sex worker leaders in East Africa hosted in Kenya.

The training aimed at equipping sex worker-led organizations with knowledge on SDGs and how they can integrate them into their programming.

AHEA Conference 2024

5th – 9th November 2024





Two UNESO staff members were able to attend the Appreciation for Activists and HRDs in East Africa Awards and Conference in Kenya. The conference brought together activists across Africa to steer conversations around acknowledging community milestones and fostering partnerships within the continent to help bridge the gaps in our movement.

Also, during the Awards, Ms. Namakula Nakato Daisy the National Coordinator was awarded the Best Human Rights and Activists in Uganda 2024 Award and Nassuna Stellah was awarded Hall of Feme Activist & HRD of the Year 2024.

Partner Engagements

At UNESO, we believe in the power of collaborations and partnerships in the journey to the realization of sex workers' rights. Over the quarter we have been able to attend different partner engagements as listed below.



UNESO attended the WONETHA reflection meeting to review a position paper on the influence of the legal regime on the work and lives of female sex workers in Uganda. The paper was to show the position stand of WONETHA and the sex worker movement on the criminalization of sex work and its impact to the live of workers.

UNESO attended the National CLM Dialogue for Key Populations organized by the CLM consortium. During the meeting, CLM team got to share with us the key findings from the recently completed DIC monitoring exercise and held a panel to deliberate on the best practices adopted by key population organizations in response to DIC operations amidst the challenging context.





UNESO was presenting at the National Dissemination and Data Utility of the findings of the Bio-Behavioural survey among Female Sex Workers in 12 districts in Uganda.

One of the key findings was - Overall HIV prevalence among sex workers of all age

groups is at 33% - 54% Mbarara - 45% Masaka 44% Fortportal.

The National Coordinator of UNESO attended the Defend Defenders Interactive Dialogue Meeting with the United Nations Special Procedures and the African Commission on Human and People's Rights Special Mechanisms. The meeting aimed to strengthen the synergy between Ugandan HRDs and the regional and international Human Rights systems to enhance access and the ability to engage effectively.





UNESO was part of the Bi-Annual Sexual and Reproductive Health and Rights (SRHR) Movement Retreat convened by CEHURD to evaluate progress and strategize advocacy efforts for the future.

UNE was part of a 2-day Training on MPOX organized by the World Health Organization through MARPI Mulago. The training aimed at equipping KP leaders with key knowledge and information on MPox Disease and finding strategies on how to minimize the risks among KPs.
